2 - Definition of Terms

Parent/Carer - the adult the academy and/or local authority decides is most appropriate to work with, including:

- All natural parents, whether they are married of not
- All those who have parental responsibility for a child or young person
- Those who have day-to-day responsibility for the child (i.e. lives with and looks after them)

School Day - Excludes weekends and academy holiday and period of partial or total academy closure

Trust - The Transforming Lives Academy Trust

3 - Rationale and Statutory Requirements

- 3.1 This policy demonstrates the Trust's commitment to meeting our obligations with regards to school attendance, including those laid out in the Department for Education's (DfE) statutory guidance on <u>working together to improve school attendance</u> (19 August 2024), through our whole-school culture and ethos that values good attendance.
- 3.2 The statutory guidance is based on the following pieces of legislation, which set out the legal powers and duties that govern school attendance:
 - Part 6 of the Education Act 1996
 - Part 3 of the Education Act 2002
 - Part 7 of the Education and Inspections Act 2006
 - The Education (Pupil Registration) (England) Regulations 2006 (and 2010, 2011, 2013, and 2016 amendments)
 - The Education (Penalty Notices) (England) (Amendment) Regulations 2013
 - It also refers to:
 - Keeping Children Safe in Education
 - o Mental health issues affecting a pupil's attendance: guidance for schools
 - o Children Missing in Education Sept 25
- 3.3 This policy also complies with our trust's funding agreement and articles of association.

4.1 Roles & Responsibilities

4.1.1 The Board of Trustees

The Board of Trustees is responsible for:

- Setting high expectations of all Trust and Academy Leaders
- Making sure academy leaders fulfil expectations and statutory duties, including:
 - Making sure schools record attendance accurately in the register, and share the required information with the DfE and local authorities
 - Making sure all schools in the Trust work effectively with local partners to help remove barriers to attendance, and keep them informed regarding specific pupils, where appropriate
- Recognising and promoting the importance of school attendance across the trust's policies and ethos
- Regularly reviewing and challenging attendance data and helping Trust leaders focus improvement efforts
- Working with Trust Leaders to set goals or areas of focus for attendance and providing support and challenge
- Ensuring that the sharing of effective practice on attendance management and improvement takes place across the trust and that this provides regular opportunities for staff from different academies to come together, learn from each other and share resources.

4.1.2 The Local Governing Board

The LGB's are responsible for:

- Setting high expectations of academy leaders
- Making sure academy leaders fulfil expectations and statutory duties, including:
 - Making sure the academy records attendance accurately in the register, and share the required information with the DfE and local authorities
 - Making sure the academy works effectively with local partners to help remove barriers to attendance, and keep them informed regarding specific pupils, where appropriate

- Recognising and promoting the importance of attendance across the academy's policies and ethos
- Making sure the academy's attendance management processes are delivered effectively, and that consistent support is provided for pupils who need it most by prioritising staff and resources
- Making sure the academy has high aspirations for all pupils, but adapts processes and support to pupils' individual needs
- Regularly reviewing and challenging attendance data and help academy leaders focus improvement efforts
 on individual pupils or cohorts who need it most, through the item being scrutinized termly as part of the
 Academy Evaluation Statement agenda item.
- Working with the Trust and academy leaders to set goals or areas of focus for attendance and providing support and challenge
- Monitoring attendance figures for the whole academy and repeatedly evaluating the effectiveness of the school's processes and improvement efforts to make sure they are meeting pupils needs
- Where the academy is struggling with attendance, working with academy leaders to develop a comprehensive action plan to improve attendance
- Making sure all staff receive adequate training on attendance as part of the regular continued professional development offer, so that staff understand:
 - The importance of good attendance
 - That absence is almost always a symptom of wider issues
 - o The academy's legal requirements for keeping registers
 - The academy's strategies and procedures for tracking, following up on and improving attendance, including working with partners and keeping them informed regarding specific pupils, where appropriate
- Making sure dedicated training is provided to staff with a specific attendance function in their role, including
 in interpreting and analysing attendance data
- Holding the Principal to account for the implementation of this policy

4.1.3 The Principal

The Principal is responsible for:

- The implementation of this policy at the school
- Monitoring school-level absence data and reporting it to governors
- Supporting staff with monitoring the attendance of individual strategies
- Issuing fixed-penalty notices, where necessary and/or authorising role to be able to do so
- Working with the parents of pupils with special educational needs and/or disabilities (SEND) to develop specific support approaches for attendance for pupils with SEND, including where school transport is regularly being missed, and where pupils with SEND face in-school barriers
- Communicating with the local authority when a pupil with an education, health and care (EHC) plan has

falling attendance, or where there are barriers to attendance that relate to the pupil's needs

• Communicating the school's high expectations for attendance and punctuality regularly to pupils and parents through all available channels

4.1.4 The Trust Attendance Lead

The Trust Attendance Lead is responsible for:

- Driving attendance improvement across the trust
- Working more intensively with schools who require support to improve attendance
- Acting as a central contact point for schools with attendance queries
- Liaising with the DfE's regional teams for advice about wider support programmes

4.1.5 The Designated Senior Leader responsible for attendance

The Designated Senior Leader in each academy (also known as the Senior Attendance Champion) is responsible for:

- Leading, championing and improving attendance across the academy
- Setting a clear vision for improving attendance across the academy
- Evaluating and monitoring expectations and processes
- Having a strong grasp of absence data and oversight of absence data analysis
- Regularly monitoring and evaluating progress in attendance
- Establishing and maintaining effective systems for tackling absence, and making sure they are followed by all staff
- Liaising with pupils, parents/carers and external agencies, where needed
- Building close and productive relationships with parents to discuss and tackle attendance issues
- Creating intervention or reintegration plans in partnership with pupils and their parents/carers
- Delivering targeted intervention and support to pupils and families

4.1.6 The Academy Attendance Officer

The Academy Attendance Officer at each academy is responsible for:

- Monitoring and analysing attendance data
- Benchmarking attendance data to identify areas of focus for improvement
- Providing regular attendance reports to academy staff and reporting concerns about attendance to the Designated Senior Leader responsible for attendance, and the Principal
- Working with education welfare officers to tackle persistent absence
- Advising the Principal when to issue fixed-penalty notices

4.1.7 Class Teachers/Form Tutors

The Class Teachers/Form Tutors are responsible for:

- For recording attendance for both morning and afternoon sessions on a daily basis, using the correct codes (see Appendix 1) and submitting this information to the school office by the end of the registration period.
- All teachers should be committed to building strong relationships with families to make sure pupils have an
 expectation to attend school and to offer any relevant support.

4.1.8 Academy Pastoral Staff (with attendance as part of their remit)

Pastoral Staff monitor and analyse the attendance data of their cohorts

- Monitor and analyse the attendance of pupils in their cohort
- Work with the Academy Attendance Officer to provide individual support to pupils whose attendance is of concern and to tackle persistent absenteeism within their cohort.

4.1.9 Administration and Office Staff

Administration and office staff will:

- Take calls from parents/carers (and Post-16 students when applicable) about absence on a day-to-day basis and record it on the school system
- Transfer calls from parents/carers (and Post-16 students when applicable) to the relevant where appropriate, in order to provide them with more detailed support on attendance.

4.1.10 Parents/Carers

Where this policy refers to a parent, it refers to the adult the academy and/or local authority decides is most appropriate to work with, including:

- All natural parents, whether they are married or not
- All those who have parental responsibility for a child or young person
- Those who have day-to-day responsibility for the child (i.e. lives with and looks after them)

Parents are expected to:

- Make sure their child attends every timetabled session on time
- Report their child's absence via the Studybugs app or 'report an absence' tab on the academy website. This should be completed by 9.00 on the day of the absence and each subsequent day of absence, and advise when they are expected to return
- Provide the school with more than one emergency contact number for their child
- Ensure that, where possible, appointments for their child's are made outside of the school day
- Keep to any attendance contracts that they make with the school and/or local authority
- Seek support, where necessary, for maintaining good attendance, by contacting Mrs J Flaig, our Home School Support Worker who can be contacted via –

4.1.11 Pupils

Pupils are expected to:

- Primary Academies: Attend school every day, on time
- Secondary Academies: Attend every timetabled session, on time

5 - Principles

- 5.1 Our policy is underpinned by the setting of high expectations for the attendance and punctuality of all pupils.
- 5.2 Its principles are:
 - Promoting good attendance and the benefits of good attendance
 - Reducing absence, including persistent and severe absence
 - Ensuring every pupil has access to the full-time education to which they are entitled
 - Acting early to address patterns of absence
 - Building strong relationships with families to make sure pupils have the support in place to attend school

We will also promote and support punctuality in attending lessons.

6 - Policy Statement

- 6.1 This policy is based on the Department for Education's (DfE's) statutory guidance on <u>working together to improve</u> <u>school attendance (19 August 2024)</u> and <u>school attendance parental responsibility measures</u>.
- 6.2 TLET's emphasis is on developing an academy culture and climate which builds a sense of connectedness and belonging to ensure all children can attend school and thrive. The approach ensures we prioritise building strong working relations with our pupils and their parents prior to any escalation.

7 - Procedure

Recording Attendance

7.1 Recording Attendance

We will keep an electronic attendance register and place all pupils onto this register.

We will take our attendance register at the start of the first session of each school day and once during the second session. It will mark, using the appropriate national attendance and absence codes from School Attendance (Pupil Registration) (England) Regulations 2024, whether every pupil is:

- Present
- Attending an approved off-site educational activity
- Absent
- Unable to attend due to exceptional circumstances

Any amendment to the attendance register will include:

- The original entry
- The amended entry
- The reason for the amendment
- The date on which the amendment was made
- The name and position of the person who made the amendment

See Appendix 1 for the DfE attendance codes.

We will also record:

- Whether the absence is authorised or not
- The nature of the activity, where a pupil is attending an approved educational activity

The nature of circumstances, where a pupil is unable to attend due to exceptional circumstances

We will keep every entry on the attendance register for 6 years after the date on which the entry was made.

At Grenville, the academy day starts at 8.40 and ends at 3.15. Pupils must arrive by 8.45.

The register for the morning will be taken at 8.45 and will be kept open until 9.15. the register for the afternoon session will be taken at 1.00 and will be kept open until 1.30.

At Cornwallis, the academy day starts at 8.45 and ends at 3.30. Pupils must arrive by 8.55.

The register for the morning will be taken at 8.55 and will be kept open until 9.25. The register for the afternoon session will be taken at 1.15 and will be kept open until 1.45.

7.2 Unplanned absence

The pupil's parent/carer must notify the academy of the reason for the absence on the first day of an unplanned absence by 9.00, or as soon as practically possible, by recording this on the Studybugs app or 'Report and absence' tab on the academy website.

We will mark absence due to physical or mental illness as authorised unless the academy has a genuine concern about the authenticity of the illness.

Where the absence is longer than 5 days or there are doubts about the authenticity of the illness, the academy will ask for medical evidence, such as a doctor's note, prescription, appointment card or other appropriate form of evidence. We will not ask for medical evidence unnecessarily.

If the academy is not satisfied about the authenticity of the illness, the absence will be recorded as unauthorised and parents will be notified of this in advance.

7.3 Planned absence

Attending a medical or dental appointment will be counted as authorised as long as the pupil's parents/carer notifies the academy in advance of the appointment.

Leave of absence should be requested by using the Leave of Absence form which can be requested from the Office or found here. All completed forms should be handed in to the Office.

However, we encourage parents/carers to make medical and dental appointments out of school hours where possible. Where this is not possible, the pupil should be out of school for the minimum amount of time necessary.

The pupil's parent/carer must also apply for other types of term-time absence as far in advance as possible of the requested absence. Go to section 5 to find out which term-time absences the school can authorise.

7.4 Lateness and punctuality

A pupil who arrives late:

• Before the register is closed will be marked as late, using the appropriate code TLET Policy Attendance Policy | September 2025

- After the register has closed will be marked as absent, using the appropriate code
- **Grenville** The AM registers close at 9.15. If a pupil arrives past this time, they will be marked as 'unauthorised' (arrival after registration)/ U code.
- **Cornwallis** The AM registers close at 9.25. If a pupil arrives past this time, they will be marked as 'unauthorised' (arrival after registration)/ U code.

7.5 Following up unexplained absence

Where any pupil we expect to attend school does not attend, or stops attending, without reason, the academy will:

- When an unauthorised absence (N" code) is recorded on the register, this signals that a parent or carer hasn't reported their child's absence. At 9.30, this will trigger an automatic notification via Studybugs to prompt parents/carers to do so. The message will inform them that the school has no record of the child's absence and requests them to report it using the Studybugs app or website as soon as possible
- If no response has been received by 10.00, a phone call will be made to the pupil's parent/carer to ascertain the reason. If the school cannot reach any of the pupil's emergency contacts, the academy may contact other agencies e.g. the police, social care or an appropriate safeguarding body
- Schools have a safeguarding role, so home visits may be made, by school staff and on occasion by the Local Authority Link Attendance Office, if a parent cannot be otherwise contacted
- Identify whether the absence is approved or not
- Identify the correct attendance code to use and input it as soon as the reason for absence is ascertained this will be no later than 5 working days after the session(s) for which the pupil was absent
- Call the parent on each day that the absence continues without explanation, to make sure proper safeguarding
 action is taken where necessary. If absence continues, the academy will consider involving an education welfare
 officer
- Where relevant, report the unexplained absence to the pupil's youth offending team officer
- Where appropriate, offer support to the pupil and/or their parents to improve attendance
- Identify whether the pupil needs support from wider partners, as quickly as possible, and make the necessary referrals
- Where support is not appropriate, not successful, or not engaged with: the academy may issue a notice to improve, penalty notice or other legal intervention.

7.6 Following up unexplained absence

The academy will regularly inform parents (see definition of 'parent') about their child's attendance and absence levels in keeping with the academy's reporting schedule. Eg, Studybugs notifications, letters, parents evening and termly written reports.

7.7 Authorised and unauthorised absence

Approval for term-time absence

The Principal will allow pupils to be absent from the school site for certain educational activities, or to attend other schools or settings.

The Principal will only grant a **leave of absence** to a pupil during term time if the request meets the specific circumstances set out in the <u>2024 school attendance regulations</u>. These circumstances are:

- Taking part in a regulated performance, or regulated employment abroad
- Attending an interview
- Study leave
- A temporary, time-limited part-time timetable
- Exceptional circumstances

A leave of absence is granted at the Principal's discretion, including the length of time the pupil is authorised to be absent for.

Leave of absence will not be granted for a pupil to take part in protest activity during school hours.

As a leave of absence will only be granted in exceptional circumstances, it is unlikely a leave of absence will be granted for the purposes of a family holiday.

The school considers each application for term-time absence individually, taking into account the specific facts, circumstances and relevant background context behind the request.

Any request should be submitted as soon as it is anticipated and, where possible, at least four weeks before the absence, and in accordance with any leave of absence request form, accessible here. The Principal may require evidence to support any request for leave of absence. If a pupil is over compulsory school age (e.g. sixth form), leave can be requests or agreed by the pupil or a parent they normally live with.

Other valid reasons for **authorised absence** include (but are not limited to):

- Illness (including mental-health illness) and medical/dental appointments
- Religious observance where the day is exclusively set apart for religious observance by the religious body to which the pupil's parent(s) belong(s). If necessary, the school will seek advice from the parent's religious body to confirm whether the day is set apart
- Parent(s) travelling for occupational purposes this covers Roma, English and Welsh gypsies, Irish and Scottish
 travellers, showmen (fairground people) and circus people, bargees (occupational boat dwellers) and new
 travellers. Absence may be authorised only when a traveller family is known to be travelling for occupational
 purposes and has agreed this with the school, but it is not known whether the pupil is attending educational
 provision.
- If the pupil is currently suspended or excluded from school (an no alternative provision has been made)

Other reasons the academy may allow a pupil to be absent from the school site, which are not classified as absences,

include (but are not limited to):

- Attending an offsite approved educational activity, sporting activity or visit or trip arranged by the school
- Attending another school at which the pupil is also registered (dual registration)
- Attending provision arranged by the local authority
- Attending work experience
- If there is any other unavoidable cause for the pupil not to attend school such as disruption to travel cause by an emergency, a lack of access arrangements, or because the school premises are closed

7.8 Sanctions

The academies of the Trust will make use of the full range of potential sanctions - including, but not limited to, those listed below - to tackle poor attendance. Decisions will be made on an individual, case-by-case basis.

Penalty notices

The Principal (or someone authorised by them), local authority or the police can fine parents for the unauthorised absence of their child from school, where the child is of compulsory school age, by issuing a penalty notice.

If the academy issues a penalty notice, it will check with the local authority before doing so, and send it a copy of any penalty notice issued.

Before issuing a penalty notice, the academy will consider the individual case, including:

- Whether the national threshold for considering a penalty notice has been met (10 sessions of unauthorised absence in a rolling period of 10 school weeks)
- Whether a penalty notice is the best available tool to improve attendance for that pupil
- Whether further support, a notice to improve or another legal intervention would be more appropriate solution
- Whether any obligations that the school has under Equality Act 2010 make issuing a penalty notice inappropriate

A penalty notice may also be issued where parents allow their child to be present in a public place during school hours without reasonable justification, during the first 5 days of a suspension or exclusion (where the school has notified the parents that the pupil must not be present in a public place on that day).

Each parent who is liable for the pupil's offence(s) can be issued with a penalty notice, but this will usually only be the parent/parents who allowed the absence.

The payment must be made directly to the local authority, regardless of who issues the notice. If the payment has not been made after 28 days, the local authority can decide whether to prosecute or withdraw the notice.

If issued with a **first** penalty notice, the parent must pay £80 within 21 days, or £160 within 28 days.

If a **second** penalty notice is issued to the same parent in respect of the same pupil, the parent must pay £160 if paid within 28 days.

A **third** penalty notice cannot be issued to the same parent in respect of the same child within 3 years of the date of the issue of the first penalty notice. In a case where the national threshold is met for a third time within those 3 years, alternative action will be taken instead.

Notices to improve

If the national threshold has been met and support is appropriate, but parents do not engage with offers of support, the academy may offer a notice to improve to give parents the final chance to engage with support.

Notices to improve will be issued in line with processes set out in the local code of conduct for the local authority area in which the pupil attends school.

They will include:

- Details of the pupil's attendance record and of the offences
- The benefits of regular attendance and the duty of parents under section 7 of the Education Act 1996
- Details of the support provided so far
- Opportunities for further support, or to access previously provided support that was not engaged with
- A clear warning that a penalty notice may be issued if attendance doesn't improve within the improvement
 period, along with details of what sufficient improvement looks like, which will be decided on a case-by-case
 basis
- A clear timeframe of between 3 and 6 weeks for the improvement period
- The grounds on which a penalty notice may be issued before the end of the improvement period

7.9 Strategies for promoting attendance

The class teacher is your primary point of contact and an invaluable resource. They build the strongest relationship with your child over time, getting to know them, the daily school routine, and the classroom environment best.

If your child is experiencing difficulties with attendance, please speak to the class teacher first. They can offer reassurance, consider any potential barriers to your child feeling comfortable at school, and work with you to find a solution. In many cases, this informal level of support is enough to remove worries and resolve attendance concerns quickly.

However, it is important to know that further support may sometimes be necessary. This is absolutely fine and not a cause for alarm. Getting other staff members or specialized support involved can be the key to overcoming more complex concerns.

Crucially, communication and engagement from everyone is vital at every stage. We can only help if we know there is a concern. Let us know so we can work together to ensure your child is happy and thriving in school.

The Studybugs app will be used to inform parents/carers when -

- Their child's attendance drops below 96%
- Their child's attendance drops below 93% and they are at risk of Persistent Absence
- Their child's absence drops below 90% and they are classed as Persistently Absent

The Studybugs app will be used to celebrate with parents/carers when -

- Their child achieves 100% attendance over a half term
- Their child achieves 100% attendance over an academic year
- Their child's attendance increases to above 96%
- Their child's attendance increases above 90% and they are no longer Persistently Absent

7.10 Supporting pupils who are absent or returning to school

Pupils absent due to complex barriers to attendance

The academy will work individually with the pupil and parents/carers to try and remove in-school barriers affecting attendance. These actions/activities will be delivered on an individual case-by-case basis.

Pupils absent due to mental or physical ill health

The academy will work closely with the pupil and parents/carers of pupils whose attendance is affected by mental or physical ill health or SEND. Supportive actions and activities will be bespoke to the individual needs of the pupil.

Where a pupil has an education health and care (EHC) plan and their attendance falls, or the academy become aware of barriers to attendance that are related to the pupil's needs, the academy will inform the local authority.

Pupils returning to school after a lengthy or unavoidable period of absence

The academy will work closely with the pupil and parents/carers where there has been a lengthy period of absence. Each case will be treated individually and a bespoke reintegration plan will be devised employing strategies that will bring about timely and effective reintegration.

TLET academies work closely with Warwickshire County Council and supports the Warwickshire Targeted Attendance Support Pathway (Appendix2).

Children Missing in Education (CME)

CME are children of compulsory school age who are not registered pupils at a school and are not receiving suitable education otherwise than at a school.

CME includes children who:

- are in the process of applying for a school place.
- have been offered a school place for a future date but have not yet started
- are receiving elective home education (EHE) that has been assessed as unsuitable
- have been recorded as CME for an extended period of time, for example where their whereabouts is unclear or unknown

TLET academies will:

- <u>maintain accurate admission registers</u> and take a proactive approach to monitoring pupils' attendance in line with chapter 2 of <u>Working together to improve school attendance</u>
- do their own initial proactive work to locate a child at risk of becoming a CME, before working jointly with their local authority to conduct further reasonable enquiries to identify their whereabouts schools should also continue to play their role in conducting joint reasonable enquiries even after they have submitted a CME referral to the local authority (refer to making reasonable enquiries)
- work collaboratively with their local authority to return CME in their local area into education this might also involve working with a child's home local authority, if different
- offer appropriate support to successfully integrate children into their school, including having efficient decision making processes for admissions in place to prevent delays
- carefully follow guidance on removing or adding pupils' names from or to the admission register, which in some specific cases will involve joint actions to be undertaken between the school and local authority before this decision can be made
- follow the TLET Safeguarding and Child Protection Policy if there is a concern that a child identified as CME is at risk. Where designated safeguarding leads or any staff in schools or local authorities have concerns about a child's welfare, they should immediately consider whether a referral needs to be made to local authority children's social care and, if appropriate, whether to call the police if there is a concern that the child is suffering or is likely to suffer significant harm.

7.11 Attendance monitoring

At Trust Level

The Trust Executive Team will monitor attendance and absence data (including punctuality) weekly, half-termly and annually across the school by year, class group (where appropriate) and pupil characteristic (including those pupils who are severely or persistently absent). This is achieved using FFT Aspire. The Trust benchmark its attendance data at whole Trust and individual academy level by year group and cohort level against local, regional, and national levels to identify areas of focus for improvement. Attendance information is reported to the Safeguarding and Standards Committee and to the Trust Board.

At Academy Level

Henry Hinde School has granted the DfE access to its management information system so that data can be accessed regularly and securely. Data will be collected each term and published at national statistics releases. The underlying school-level absence data is published alongside the national statistics.

Henry Hinde School monitors and tracks attendance daily and any concerns are reported to the Attendance Team via the Studybugs Dashboard and alert system. The Attendance Team meet every 3 weeks to discuss pupils whose attendance has fallen to 95% or below. A staged approach is then applied.

Staged Approach to Promoting Attendance

Stage 1 Support - Initial Concerns

- If a child's attendance is at 95% or below
- The Attendance Team will send **Notification 1** to parents/carers via the Studybugs app. This message will inform parents/carers of their child's current attendance and offer them the opportunity to speak with a member of school staff either by telephone or face to face. Please remember that this invitation is purely for **support**. It's a positive step designed to help you and your child overcome any difficulties and ensure they can attend school happily and consistently.

Stage 2 Support - Continued Concerns

- If a child's attendance falls below 93%
- The Attendance Team will send **Notification 2** to parents/carers via Studybugs to invite them in for a meeting with the **Attendance Lead/Vice Principal and/or Home School Support Worker**.
- The core aim of this meeting is to understand and address the barriers to your child's regular attendance. We will actively seek your and your child's perspective on what is making school difficult and share our concerns regarding the current level of attendance. Attendance which drops below 90% is identified as Persistent Absence.
- Together, we will agree upon an **Attendance Support Plan**. This formal plan clearly sets out the responsibilities of the school, you as a parent, and your child, ensuring everyone is working towards the same goal. The support offered may include resources within the school or signposting to external agencies and support channels that you may choose to engage with.
- Attendance will be monitored each Friday for a fixed period of 4 weeks.
- A review date will be agreed

Stage 3 Support

- If the child's attendance falls below 90%
- Any attendance that falls below 90% for a school year (which is 19 or more days absence across the school year) is termed as 'persistent absence' by the government.
- A formal letter will be sent to the parent/carer with an **appointment to meet with the Principal/Vice Principal**.
- The purpose for this is to discuss attendance, agree an **Attendance Support Plan**, consider whether it is appropriate to involve outside agencies and set an internal school attendance target.
- Attendance will be **reviewed** each Friday for a fixed period of **4 weeks** with parents, either by telephone call or in person.

Stage 4 - Referral to WAS

- Any child failing to show an appropriate level of improvement will be discussed with Warwickshire
 Attendance Service (WAS)
- If the **Attendance Support Plan** fails to work the school will then need to refer the case to the local authority for support. Once a referral to the Local Authority has been made, they then take the lead on managing support for the parent / carer and the child, with the support of the school.

The outcomes from here are:

- that support brings about an improvement in attendance and/or engagement from parents / carers over time
- attendance fails to improve and the local authority move towards either a penalty notice or even a potential conviction.

Analysing attendance

The academy will:

- Analyse attendance and absence data regularly to identify pupils, groups or cohorts that need additional support with their attendance
- Identify pupils whose absences may be cause for concern, especially those who demonstrate patterns and trends
- Conduct thorough analysis of weekly, half-termly, termly and full-year data to identify patterns and trends
- Look at historic and emerging patterns of attendance and absence, and then develop strategies to address these patterns
- Contribute to attendance patterns across the trust to identify common issues and barriers and share effective practice between academies

Using data to improve attendance

The academy will:

- Develop targeted actions to address patterns of absence (of all severities) of individual pupils, groups or cohorts that it has identified via data analysis
- Provide targeted support to the pupils it has identified whose absences may be a cause for concern, especially those who demonstrate patterns of persistent or severed absence, and their families
- Provide regular attendance reports to class teachers, form tutors and relevant pastoral staff to facilitate
 discussions with pupils and families, and to the Local Governing Body and school leaders (including the Special
 Educational Needs Co-ordinator, Designated Safeguarding Lead and Pupil Premium Lead)
- Use data to monitor and evaluate the impact of any interventions put in place in order to modify them and inform future strategies
- Share information and work collaboratively with other schools in the area, local authorities and other partners where a pupil's absence is at risk of becoming persistent or severe, including keeping them informed regarding specific pupils, where appropriate

7.12 Reducing persistent and severe absence

Persistent absence is where a pupil misses 10% or more of school, and severe absence is where a pupil misses 50% or more of school. Reducing persistent and severe absence is central to the Trust and academy's strategy for improving attendance.

The academy will:

- Use attendance data to find patterns and trends to persistent and severe absence
- Consider potential safeguarding issues and, where suspected or present, address them in line with Keeping Children Safe in Education
- Hold regular meetings with the parents of pupils who the school (and/or local authority) considers to be

vulnerable or at risk of persistent or severe absence, or who are persistently or severely absent, to:

- o Discuss attendance and engagement at school
- o Listen, and understand barriers to attendance
- o Explain the help that is available
- o Explain the potential consequences of, and sanctions for, persistent and severe absence
- Review any existing actions or interventions
- Provide access to wider support services to remove the barriers to attendance, in conjunction with the local authority, where relevant
- Consider alternative support that could be put in place to remove any barriers to attendance and re-engage these pupils. In doing so, the school will sensitively consider some reasons for absence
- Implement sanctions, where necessary (see section above)

8 - Monitoring

8.1 This policy will be reviewed as guidance from the local authority and/or DfE is updated, and as a minimum annually by Sian Hartle, Director of Education. At every review, the policy will be approved by each Local Governing Body.

Appendix 2: Warwickshire's Targeted Attendance Support Pathway

In situations where attendance is not improving and:

- 1. school support and other agency support has been exhausted and/or is not working,
- 2. and/or there is evidence of a lack of parental engagement.

Schools can complete a request for additional support though the Targeted Attendance Pathway via each school's WCC allocated attendance Officer.


The pathway includes possible options for:

- Additional advice and guidance.
- Ongoing work with existing agencies/school.
- Multi-agency discussion/support plan.
- Direct work with the family (parent/pupil voice).
- WCC led Attendance Contract
- Escalation where there is a lack of evidence of parental engagement.

 - o Issue a Notice to Improve
 - o Education Supervision Order
 - o Penalty Notice
 - o S444 1/1a prosecution
 - o Consideration of application of a Parenting Order

There is a separate process for leave of absence (LOA)







Appendix 3: Warwickshire Leave of Absence Guidance

Leave of Absence

• The law states a leave of absence may only be granted by a school if an application is made in advance and if it considers there are exceptional circumstances relating to the application.

Expectations

- A leave of absence is granted entirely at the school's discretion. Permission for a Leave of Absence from a school may only be given by a person who the school's proprietor has authorised to do so (an authorised person).
- Schools must judge each application individually considering the specific facts and circumstances and relevant background context behind each request.
- Generally, a need or desire for a holiday or other absence for the purpose of leisure and recreation would not constitute an exceptional circumstance.
- Where a leave of absence is granted, the school will determine the number of days a pupil can be absent from school.
- When making an application for Leave of Absence parents are advised to give sufficient information and time to allow the Head teacher the opportunity to consider all the exceptional circumstances and to notify the parents of their decision. The school may also request further information on the application and supporting documentation where appropriate.
- It is advised that if the resident parent has not received notification or a response regarding the leave of absence application, it is their responsibility to ascertain if the leave is authorised prior to the start of the leave.
- The school can only consider applications for Leave of Absence which are made by the resident parent. i.e the parent with whom the child normally resides.
- Where applications for Leave of Absences are made in advance and refused, the child is expected to be in school on the dates set out in the application. If the child is absent during that period, it will be recorded as an "unauthorised" absence. Where a leave of absence is requested but additional days take either prior to or after the request, they may be considered as part of the leave of absence.
- Leave of Absences which are not made in advance cannot be authorised in line with legislation. This will result in the absence being recorded as 'unauthorised'.
- All matters of unauthorised absence relating to a Leave of Absence will be referred to the Warwickshire
 Attendance Service of Warwickshire County Council. Penalty notices are issued in accordance with
 Warwickshire County Council's Code of Conduct for Penalty Notices and in the first instance, as an
 alternative to prosecution proceedings.
- Where a Penalty Notice is not paid within the timeframe set out in that Notice, the matter will be referred to Warwickshire County Council's Legal Services to consider instigating criminal prosecution proceedings under S444 of Education Act 1996.

Leave of Absence taken in the academic year 2024-25

The law relating to Penalty Notices changed with effect from 19 August 2024. Therefore, Penalty Notices issued for Leave of Absence taken from September 2024 will be issued in accordance with the updated legislation.

Penalty Notices are issued to <u>each parent of each absent child</u>, (for example 2 children and 2 parents, means <u>each</u> parent will receive 2 invoices – 4 in total).

- First Leave of Absence Offence: The amount of £160 to be paid within 28 days, this is reduced to £80 each child if paid within 21 days.
- Second Leave of Absence Offence within a 3 year period (from the date of issue of the first penalty notice): The amount of £160 paid within 28 days. No reduced amount.
- Third Leave of Absence offence within a 3 year period (from the date of issue of the first penalty notice). A Penalty Notice will not be issued and the matter will be referred to Warwickshire County Council's Legal Services to consider instigating criminal prosecution proceedings under S444 of Education Act 1996.
